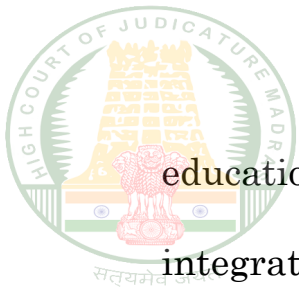

### **ORDER**

Considering the facts and circumstances of the case and taking note of the submissions made on behalf of the respondents, there shall be a direction to the petitioner to appear before the 2<sup>nd</sup> respondent along with all the relevant documents. If the 2<sup>nd</sup> respondent has any query, the same can be clarified from the petitioner and a decision shall be taken within a period of four weeks from the date of receipt of a copy of this order. 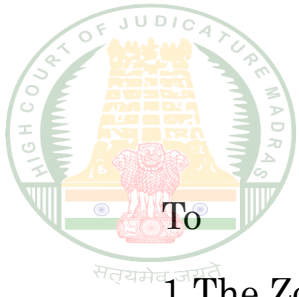
