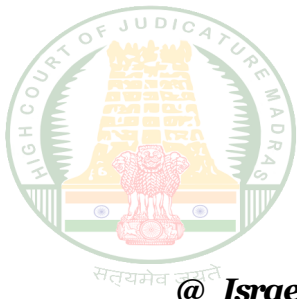
COMMON JUDGMENT
