ORDER

3. The petitioner is placing reliance upon the settlement deed dated 25.11.2014. The petitioner is also placing reliance upon the joint patta in Patta No.1498. The petitioner submitted the online application by paying necessary charges on 21.02.2025 seeking for conducting survey in the subject property. Since the same was not acted upon, the present writ petition came to be filed before this Court.

4. Taking into consideration the facts and circumstances of the case and considering the materials placed before this Court, there shall be

a direction to the respondents to act upon the online application submitted by the petitioner on 21.02.2025 and conduct survey in the subject property based on the title documents and the joint patta that stands in the name of the petitioner. This process shall be completed within a period of four weeks from the date of receipt of a copy of this order. If there are any interested parties, such survey shall be conducted in their presence.

This Writ Petition is disposed of in the above terms. There shall be no order as to costs.
