There are two photographs annexed to the petition. Half a dozen times we asked counsel what these photographs mean and to identify the encroachments from the photographs. Counsel did not answer.

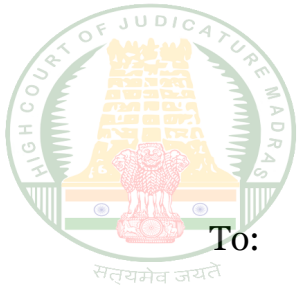
Petition is dismissed. There shall be no order as to costs.
