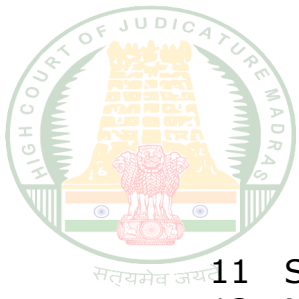

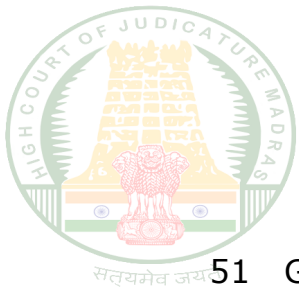

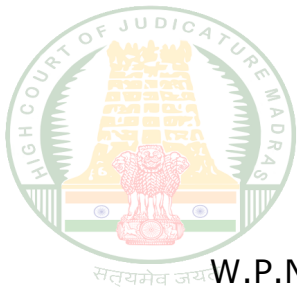

5.This review application is allowed. No costs.

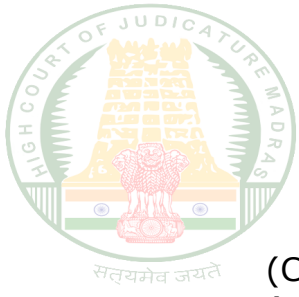
