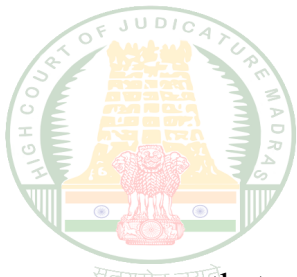

2. Heard the counsel for both sides and perused the materials available on record.

Considering the submissions, this Court is inclined to modify condition No. 3 imposed in C.M.P.No.1876 of 2024, dated 12.02.2025, passed by the learned Special Judge for EC/NDPS Act Cases, Salem, to the effect that the petitioners shall appear before the respondent Police Station daily, morning at 10:00 a.m. and evening at 5:00 p.m. for a period of thirty days and thereafter as and when required for interrogation.
