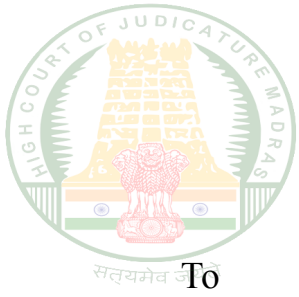
2.Heard the learned counsel for petitioner.
