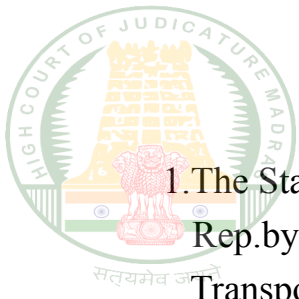

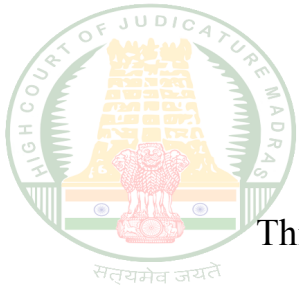

2.Heard the learned counsel for the petitioners and the learned Government Advocate for the respondents.

3.Even according to the petitioners, the representations were submitted on 03.01.2013 and 01.02.2013, but the writ petition was filed in the year 2019. Having slept over the matter for a period of 11 years from the date of submitting the representations, the petitioners have now filed the writ petition. Therefore, the prayer sought for in this writ petition cannot be considered. The writ petition is devoid of merits and it is liable to be dismissed.
