WEB COPY By consent of learned counsel on both sides, this writ petition is taken up for final disposal at the admission stage itself.

2. The present writ petition is filed praying for a writ of mandamus, directing the respondent to measure and fix boundary stones to the petitioners land comprised in Old R.S.No.133/2A1, and New R.S.No.83/3 Part, situated at Jagathala Village, Kotagiri Taluk, Coonoor, Nilgiris District measuring an extent of 20 cents by passing orders on the online application dated 15.03.2025.

It is submitted by the learned counsel for the petitioner that the petitioner submitted an application dated 15.03.2025 to the respondent to measure and fix boundary stones on the petitioner's land.
