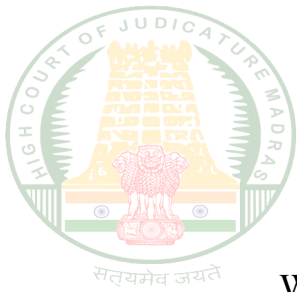

ORDER

(W.P.No.30292 of 2013, vide order dated 10.07.2017);

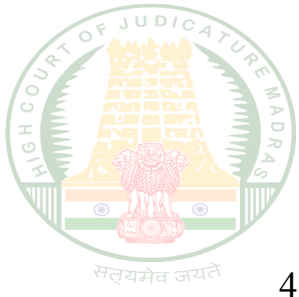
