ORDER

2.The present writ petition is filed to direct the third respondent to register the sale deed to be executed by the petitioner in favour of any third party and the 2nd respondent to effect transfer of name.

3.It is submitted by the learned counsel for the petitioner that petitioner presented a Sale Deed before the respondent 3rd respondent for registration. However, the said Sale Deed, which is sought to be registered has not been enclosed in the typed set of papers nor any refusal slip by the respondent authorities.

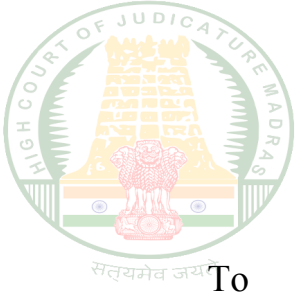
