ORDER

2.The present writ petition is filed to direct the third respondent to register the sale deed to be executed by the petitioner in favour of any third party and the 2nd respondents to effect transfer of name.

3.It is submitted by the learned counsel for the petitioner that petitioner presented a Sale Deed before the 3rd respondent for registration. However, the Sale Deed which was sought to be registered is not kept in the typed set of papers nor any refusal slip by the respondent authorities, kept.

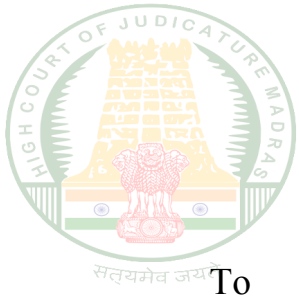
