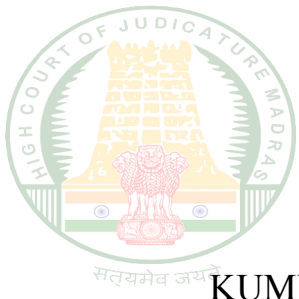

No costs. Consequently, the connected miscellaneous petition is closed.

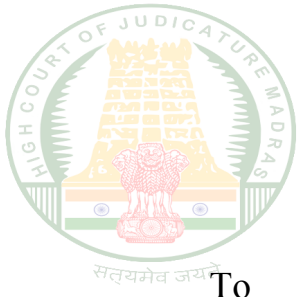
