Therefore, without going into the merits of the claim made by the petitioner, we direct the 1st respondent to consider the representation of the petitioner dated 03.01.2025 and pass appropriate orders on the same on merits and in accordance with law, after giving due opportunity of personal hearing to the petitioner, within a period of four weeks from the date of receipt of a copy of this order. Accordingly, the Writ Petition is disposed of. No costs.
