4. According to the learned Special Public Prosecutor (Income Tax), as on date no Look-Out Circular is pending against the petitioner.

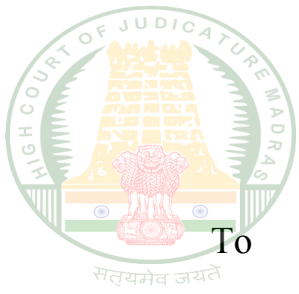
Even otherwise, the petition under Section 528 of B.N.S.S. is not maintainable regarding Look-Out Circulars issued by the Department of Income Tax.
