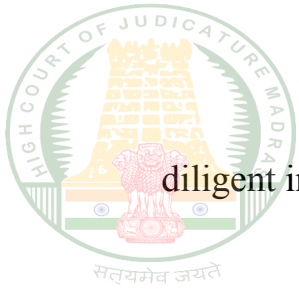

JUDGMENT

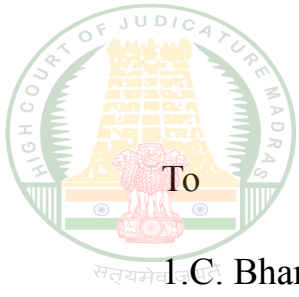
