PRAYER: Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus, to call for the records relating to the detention order dated 24/03/2025 passed by the second respondent in No.51/BCDFGISSSV/2025 and quash the same and direct the respondents herein to produce the petitioner's son namely Dhananchezhian, S/o.Elumalai, aged 24 years, No.29/28, Tamil Nadu Housing Board, 5th Main Road, Ayappakkam, Chennai-600 077, who is presently under going detention in the Central Prison, Puzhal, branding him as Goonda under Section 3(1) of the Tamilnadu Prevention of Dangerous Activities of Bootleggers, Drug offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Slum Grabbers and video Pirates Act 1982, (Tamilnadu Act 14 of 1982).
