2. Heard Mr.M.R.Elavarasan, learned counsel for petitioner and Mr.R.P.Murugan Raja, learned Government Advocate appearing for respondents.

Taking into consideration the title deed relied upon the petitioner viz., the sale deed dated 15.06.2021 and also the joint patta that stands in the name of the petitioner in Patta No.2497, there shall be a direction to the petitioner to submit an online application before the first respondent by paying necessary charges. On receipt of the same, the first respondent shall act upon the application and conduct survey in the subject property based on the title document and joint patta that stands in the name of the petitioner. If there are any other interested parties, such survey shall be conducted in their presence. This process shall be completed within a period of four (4) weeks from the date of receipt of
