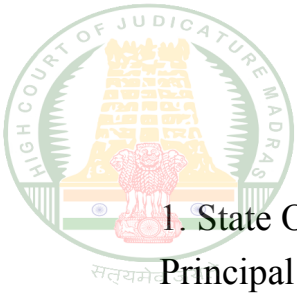

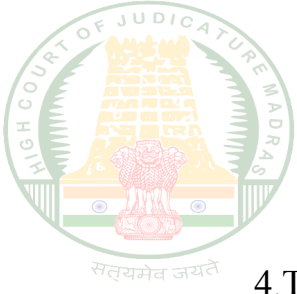
**ORDER**

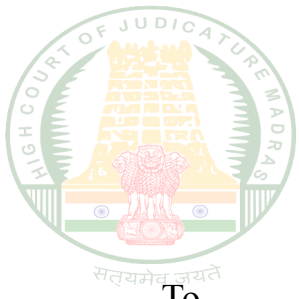
