ORDER

The instant writ petition has been filed with a prayer for issuing a Mandamus, to direct the respondents to settle the amount towards the Encashment of Earned Leaves, Surrendered by the petitioners along with 12% interest p.a.

2. It is the submission of the learned counsel for the petitioner that there is a due from the respondents in respect of the petitioners' encashment of leave salary. It is further submitted that by virtue of the reply to their RTI query, the respondents have admitted the dues payable in favour of the petitioner.

3. The learned Standing Counsel for the respondents would submit that they would make eligible payment in accordance with their record.
