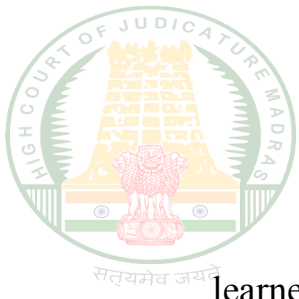

3. Despite this Court ordered private notice to the respondents 2 to 4, proof affidavit has not been filed by the petitioner so far. Since the 2nd respondent is out of the jurisdiction of this Court, this Court is not inclined to give any direction to the 2nd respondent.
