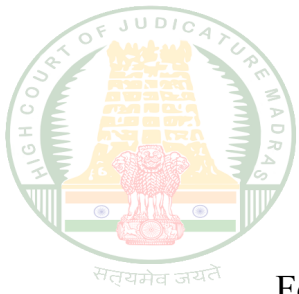

ORDER

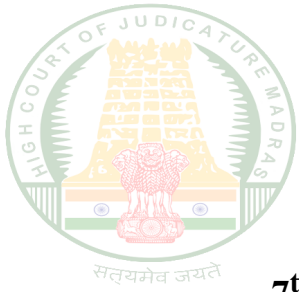
(Order of the Court was made by *M.S.RAMESH, J.*)
