The present writ petition is filed praying for a writ of mandamus, to direct the 4th respondent to consider the representation dated 27.03.2025 and issue Online Patta in favour of the Petitioner after mentioning the measurement as 440 Sq.mt., instead of 372 sq.mt., as already corrected in the Manual Patta No.225 for the property comprised in Natham Survey No.250/1, New Survey No.426/10, for an extent of 440 sq.mt., (4860 Sq.ft), situated at Mudichur Village, Tambaram Taluk, Chengalpattu District.

3. After submitting for a brief while the learned counsel for the petitioner



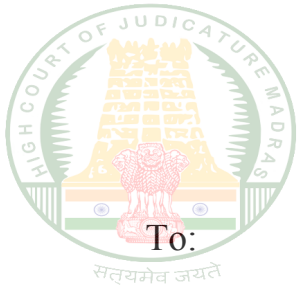
