ORDER

By consent of learned counsel on both sides, this writ petition is taken up for final disposal at the admission stage itself. In view of the order that this Court proposes to pass and also the limited relief that is sought to be granted, notice to respondent Nos.5 to 9 is dispense with.

2. The present writ petition is filed praying for a writ of mandamus to direct respondent No.3 to cancel the Patta vide Patta No.6537 issued in the name of respondent Nos.5 to 9 and issue patta in favour of petitioner and her daughter Chithra based on petitioner's appeal dated 27.03.2025 pending with respondent No.3.

3. It is submitted by the learned counsel for the petitioner that the petitioner

filed an appeal on 27.03.2025 seeking patta before the official respondents.

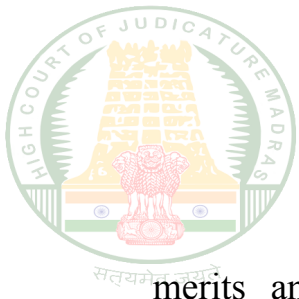
However, the said appeal has not been considered so far by the Respondents.

Aggrieved by the same, the petitioner has come before this Court.

4. It is submitted by the learned counsel for the petitioner that the petitioner's appeal though submitted as early as on 27.03.2025, is yet to be numbered.

5. At the outset, it was submitted by the learned Government Advocate for respondent Nos.1 to 4 that the appeal dated 27.03.2025, made by petitioners would be numbered within a period of two weeks from the date of receipt of a copy of this order, if it is otherwise in order, and thereafter, the concerned respondent would consider and pass orders on the petitioner's appeal dated 27.03.2025, within a time frame to be fixed by this Court, which was agreed to by the learned counsel for petitioner.

6. In view of the same, taking into consideration the facts and circumstances of the case and the limited relief sought for in this Writ Petition, there shall be a direction to the 3rd respondent, to consider the appeal dated 27.03.2025 on its own

merits and pass appropriate orders in accordance with law, after affording reasonable opportunity of hearing to the petitioner, respondents No.5 to 9 and any other interested persons/rival claimants, and also putting the respondent Nos.5 to 9 and any other interested persons/rival claimants on notice, within a period of eight (8) weeks from the date of appeal being numbered. It is made clear that this Court has not expressed any views with regard to the merits of the appeal and it is open to the concerned respondent to consider the appeal on its own merits and in accordance with law.

7. Accordingly, the writ petition stands disposed of. There shall be no order as to costs.
