2. Heard the learned counsel for both sides and perused the materials available on record.

On a perusal of the order dated 16.11.2023 in Crl.M.P.No.6087 of 2023, it is revealed that the learned Judicial Magistrate No.1, Namakkal. directed the first respondent to conduct an enquiry in the light of the directions issued by this Court in ***Sugesan Transport Private Limited -vs- Assistant Commissioner of Police, Chennai*** reported in ***(2016-5 CTC – 577)*** and file a report. However, so far, the first respondent did not conduct any enquiry and failed to comply with the order passed by the Trial Court.
