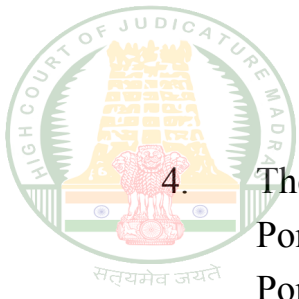

Admittedly, the land was acquired by the Government for agricultural purposes and the compensation has been received by the land owner. Thus the land absolutely vest with the Government under the provisions of the Land Acquisition Act. Thus, there is no impediment for the respondents to take possession of the land and utilise the same for public purposes.

2. As far as the claim of the petitioners/appellants that they are eligible for alternate land / resettlement is to be considered on merits during the final hearing of the present writ appeal.

3. That being so, the Stay Petition in CMP.No.9846 of 2025 and the Injunction Petitions in CMP.Nos.9849 & 9853 of 2025 are dismissed.

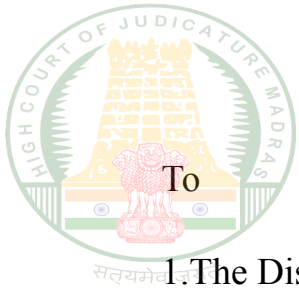
