COMMON ORDER

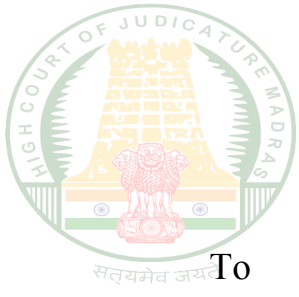
4. The abatement caused due to the death of the deceased 1st respondent is set aside and hence, C.M.P.No.9835 of 2022 is ordered as prayed for.

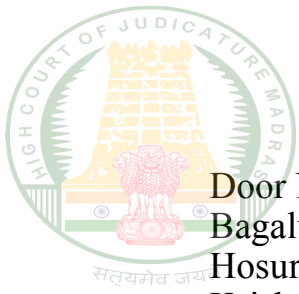
