ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

As against the allegation of erection of compound wall by 8th respondent by encroaching public street, the survey report as collected by respondent No.5, which is placed before us, shows that though certain encroachment has been found on public street, the compound wall erected by respondent No.8 does not encroach upon public street.

2. Though learned counsel for the petitioner raises a dispute with regard to the correctness of the survey report, that cannot be gone into in the writ petition.

Petition, therefore, is dismissed. There shall be no order as to costs. Consequently, the interim application also stands dismissed.
