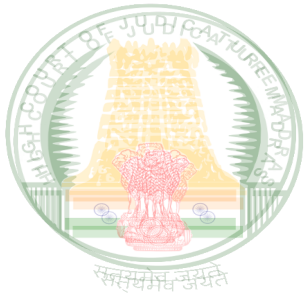

COMMON ORDER

The petitioner shall granted bail on condition and not complied the same and sought for extension of time twice. Despite such extension he has not complied the condition and this is a third petition.
