3. Recording the submissions of the learned counsel for the petitioner, this Writ Petition is dismissed as infructuous.

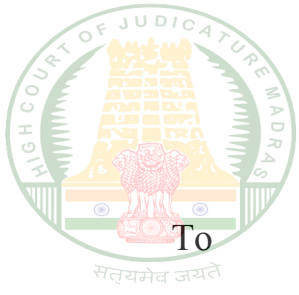
