ORDER

(Order of the Court was made by S.M.SUBRAMANIAM.J.,)

This writ petition has been filed challenging the order dated 20.11.2020 bearing reference Na.Ka.No.2661/2016/Aa4, passed by the first respondent.

2. In view of the order passed in W.A.No.1655 of 2021 relegating the parties to appear before the District Revenue Officer, Kancheepuram (now Chengalpattu) for adjudication of all the issues in entirety and directing the District Revenue Officer to pass appropriate orders, the order impugned in the present writ petition needs to be set aside. However, the merits involved in the case has to be decided uninfluenced by the earlier revenue orders passed by the District Revenue Officer.
