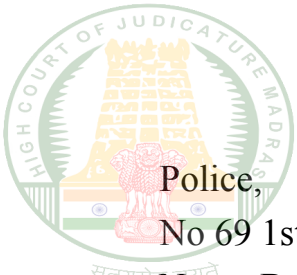

2. The learned Government Advocate (Crl.Side) on instructions submitted that a petition enquiry is pending and an FIR has not been registered.



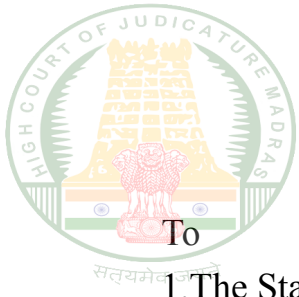
