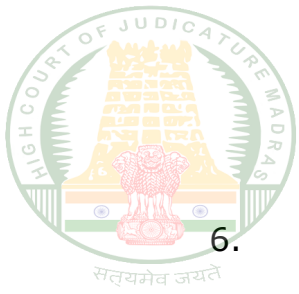

2. Pursuant to aforementioned proceedings/order, captioned 'writ petition' (hereinafter 'WP' for the sake of brevity) is listed under



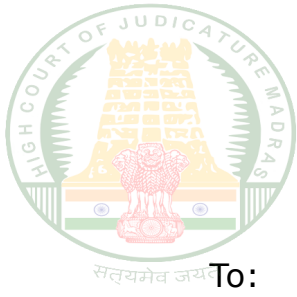
