2. Heard Mr.D.Veerasekaran, learned counsel for petitioner and Mr.A.Selvendran, learned Special Government Pleader appearing for respondent.

3. The case of the petitioner is that the subject property which belonged to the petitioner was resumed under Section 20 of the Tamil Nadu Land Reforms (Fixation of Ceiling on Land) Act, 1991. The petitioner submitted a representation to recall the said Government Order. Since the same was not acted upon, the present writ petition has been filed.

4. Taking into consideration the facts and circumstances of the case and without going into the merits of the case, there shall be a direction to the respondent to act upon the representation made by the
