When the matter was taken up for hearing today, there was no representation on behalf of the petitioner.

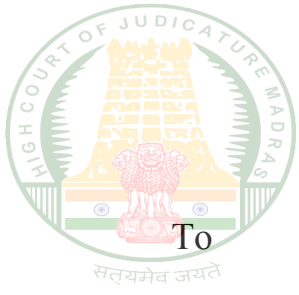
2. Accordingly, this Writ Petition is dismissed for non-prosecution.
