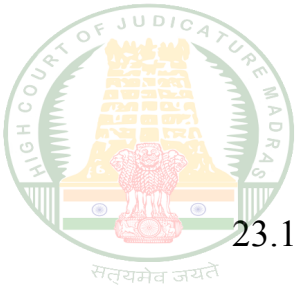

2. In view of the above, this writ petition is dismissed as withdrawn. No cost. Consequently, the connected miscellaneous petition is also closed.

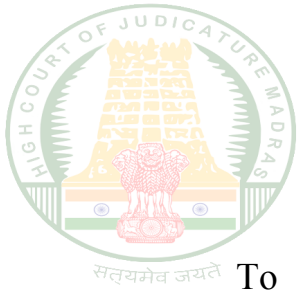
