District Magistrate and District Revenue Officer, Dharmapuri D.Dis.No. 16839/2017/C3 dated 08.03.2018 and quash the same which violates the Guidelines framed by the 2nd respondent consequently direct the Respondents 3 to 7 herein prohibit the 10th respondent therein or any one claiming or acting on his behalf either to open any petrol bunk or any retail outlet dealing with petroleum products or to function any other outlet selling petrol and diesel either under the dealership of eighth respondent or under any other dealer in S.No.316/10 and 317/1, Krishnapuram Village, Dharmapuri Taluk and District, without following the rules/guidelines by the Government of India, Ministry of Road Transport and Highways, under No.RW/NH-33023/19/99- D.O.III dated 12.04.2013

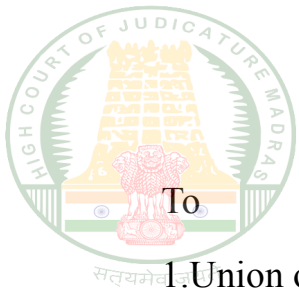
