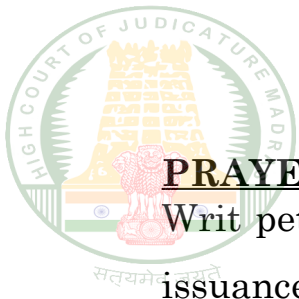

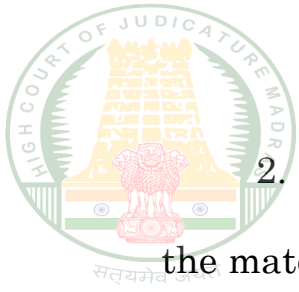
**PRAYER**

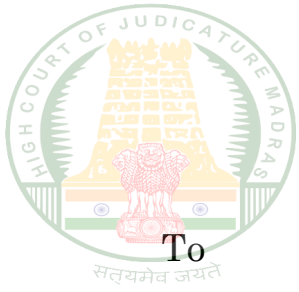
