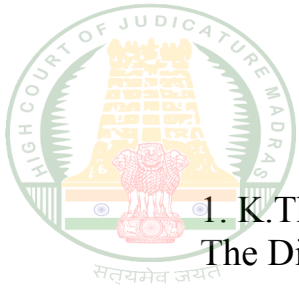
3. The learned counsel for the petitioner also accepted the said submission.
