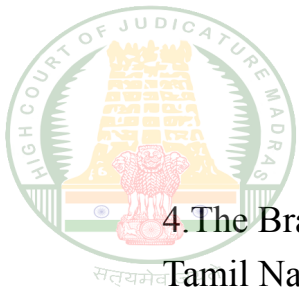

PRAYER

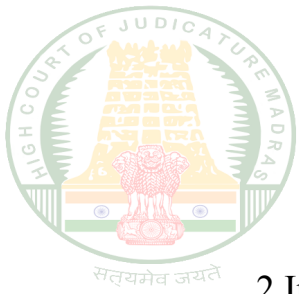
