ORDER

This Criminal Original Petition has been filed seeking a direction to the respondent to investigate the case in Crime No.28 of 2016 and to file a final report u/s 173(2) of Cr.P.C., before the Jurisdictional Court.

2. Heard the learned counsel appearing on either side and perused the materials placed on record.

3. Whenever any information in relation to commission of cognizable or non cognizable offence is received, the police officer shall adhere to the procedure contemplated under Sections 154 & 155 of the Criminal Procedure Code and after conducting necessary enquiry/investigation, file final report under Section 173 of Cr.P.C. Such investigation under Chapter XII of the Criminal Procedure Code shall be completed without any unnecessary delay. The delay in filing a final report in the present case is inordinate and unjustified. Hence, it would be appropriate to direct the Investigating Officer to file a final report within a stipulated time, if not already filed.
