2. The brief facts of the case is as follows:-

The petitioner's land was acquired by the respondents for the purpose of Chennai Airport Expansion Scheme under the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997, on 14.06.2017 based on the Notification was issued on 16.12.2007 and an award was passed only on 16.03.2020, resulting unreasonable delay of 17 years from the date of preliminary notification. The compensation amount was fixed at Rs.100/- per sq.ft. in the year 2004-2007. Now, the market value of the land is between Rs.6000/- and Rs.10,000/- per sq.ft. Therefore, he filed a petition seeking enhancement of compensation before the learned Principal District Judge, Chengalpattu, which is also pending. Therefore, the petitioner submitted a representation dated 14.02.2025, requesting for calculation and disbursement of interest component and the same was not considered till date. Hence, this petition is filed for the above relief.

3. Heard the learned counsel for the petitioner and the learned Additional Government Pleader appearing on behalf of the respondents 1 to 5.
