2. The learned counsel for the Petitioner submitted that though this writ petition has been filed for the aforesaid relief, the Petitioner has now restricted the relief and seeks liberty to file an appeal before the concerned Appellate Authority.

3. The learned Government Advocate (Tax) appearing for the Respondent submitted that she has no objection for granting such liberty to the Petitioner.

4. Considering the submissions made by the learned counsel on either side, this Court is of the opinion that it would be appropriate to
