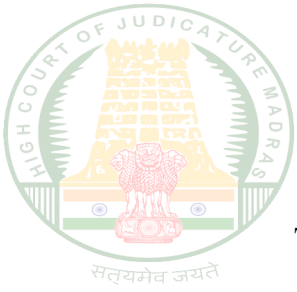

The relief sought in this writ petition is to call for the records of the Order dated 27.02.2025 bearing No.33AACCD2292C1Z6/2019-20 issued by the Respondent along with the Summary of the Order in Form GST DRC 07 dated 27.02.2025 bearing Reference No.ZD330225290300W passed for the tax period between April 2019 to March 2020 and quash the same.

2. The learned counsel for the Petitioner submitted that though this writ petition has been filed for the aforesaid relief, the Petitioner has now restricted the relief and seeks liberty to file an appeal before the concerned Appellate Authority.

3. The learned Government Advocate (Tax) appearing for the Respondent submitted that she has no objection for granting such liberty to the Petitioner.
