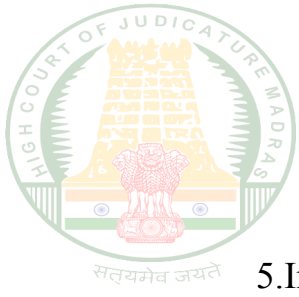

3. On going through the materials placed before this Court, it is seen that the right over the property has been conclusively decided in the Civil Court proceedings which was confirmed up to the Apex Court. The same is evident from the order passed by the Apex Court in Civil Appeal No.10583 of 2014 dated 01.05.2024. The Apex Court has taken note of the memo that was filed by the 3rd respondent on 05.04.1991 before the Trial Court to the effect that the plaintiff's in the suit are entitled for the property.

4. In the light of the above discussion, the impugned refusal Check Slip issued by the 2nd respondent asking the petitioner to get the No Objection Certificate from the 3rd respondent is unsustainable. Hence, the impugned refusal Check Slip dated 29.03.2025 issued by the 2nd respondent is hereby quashed and there shall be a direction to the 2nd respondent to register the Sale Deed, if it is otherwise in order.



5. In the result, this writ petition stands allowed with the above directions.
