The issue that is involved in the present case is squarely covered by earlier order of this Court in W.P.No.16999 of 2020 dated 03.12.2020.

4. In view of the same, the impugned refusal check slip dated 15.04.2025 issued by the second respondent is hereby quashed and there shall be a direction to the second respondent to register the Partition
