4. In view of the above, these Writ Petitions are dismissed. No costs. Consequently connected Miscellaneous Petitions are closed.

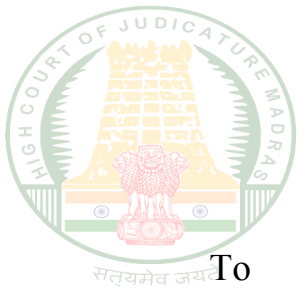
