3. Considering the submissions made and the reasons stated in the affidavit, this Court is of the view that the delay may be condoned on payment of costs, and the matter may be argued on merits.

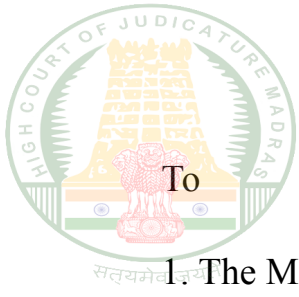
