The learned Government Advocate (crl.side) would submit that pursuant to the complaint lodged by the petitioner, a detailed enquiry was conducted and as a result, an FIR has been registered in Crime No.244 of 2025 for the offences punishable under Sections 189(2), 296(b), 329 and 126(2) of BNS as against the accused. The matter is currently pending for investigation.

4. Recording the submission made by the learned Government Advocate (crl.side), the Writ Petition stands closed. No costs. Consequently, connected miscellaneous petition is closed.
