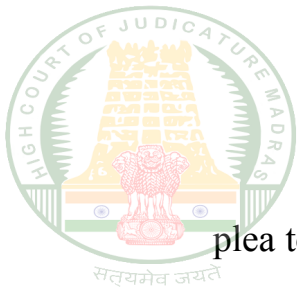

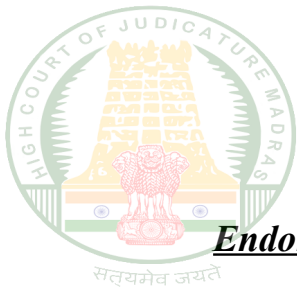
plea to preserve all the rights of the writ petitioners (if any) to seek approval
